And we are energized to change how we operate – seeking to diversify our funding, utilize data systems and talented volunteers and staff to build efficiencies, and invest in higher impact programming.



### OUR GOALS

In July 2023, the Community Solutions of Eastern Iowa Board of Directors and key staff reviewed the existing CSEI Strategic Plan, studied key data points, asked questions regarding current practices and finances, and make recommendations for the new plan. Working with a facilitator, the group arrived a the following three goals on which to focus for the next five years.

- Goal I: Ensure that our programs meet the needs of our region.
- Goal II: Secure and maintain funding to address the needs of those experiencing homelessness and housing instability.
- Goal III: Secure and maintain staffing to successfully obtain and implement the funding.

## GOAL I: ENSURE THAT OUR PROGRAMS MEET THE NEEDS OF OUR REGION

Understand the housing and homelessness climate in our region and the country.	<ul> <li>Review and understand emerging data on housing and homelessness in our region</li> <li>Participate in community action and conversation groups such as the Homeless Advisory Commission, state and federal organizations, City of Dubuque, Dubuque County, and Delaware County groups related to housing and homelessness</li> <li>Attend state/national conferences and training opportunities annually</li> <li>Add People with Lived Experience (PLE) to our committees and board</li> <li>Encourage private developers and mission-driven nonprofits who will work with CSEI programs to house the homeless.</li> </ul>
Restructure the "Homeless Hotline" to "Housing Helpline"	<ul> <li>Continue to be HUD-Appointed Coordinated Entry lead for Eastern Iowa Region (Delaware &amp; Dubuque counties) which serves Street Outreach, Rapid Rehousing and Homeless Prevention programs</li> <li>Continue to analyze Helpline data to make staffing adjustments as needed</li> <li>Continually realign partnerships for referral services</li> <li>Continue to educate the public on why it is a "Helpline" and not a "Hotline"</li> <li>Secure annual funding to staff Helpline</li> </ul>

Partnerships	<ul> <li>Continue contract of services with ECIA to provide staff, indirect and direct overhead, and cash flow.</li> <li>Provide additional services where feasible (e.g., grant writing, case management, financial) and discontinue when not.</li> </ul>
Grant Writing	<ul> <li>Identify relevant funding sources: Public &amp; Private</li> <li>Maintain appropriate staffing levels to manage grant writing.</li> </ul>
Private Fundraising	<ul> <li>Create a Fundraising Plan for the organization.</li> <li>Secure 3-6 months of private operating funds in reserve</li> <li>Create monthly "sponsors" campaign for Housing Helpline</li> <li>Transition/combine public awareness events with fundraising</li> <li>Work with Faith Communities</li> </ul>

Achieve funding levels to support needed staffing	Continue to work toward dedicated balance of staff to support CSEI functions/programs.
Offer training and education to stay current with program needs/requirements and advance skills.	Offer quality training and conference opportunities to staff.
